

Greene Valley Recreation Club Inc
Party Rental Agreement and Policies

In order to host a party at GVRC, you must be a member in good standing, as defined by the current by-laws. There are two areas available for party rental: the Woods and the Awning and three rental times for Saturday and Sunday. Parties will run no longer than 3hrs including set up and clean up.

Fees are \$50 plus a \$25 refundable deposit. This provides use of designated area, tables, pool and grill (charcoal for Woods, gas for Awning) for **25 people (total of member and non-member)**. Each additional non-member guest will be \$5. Party guests will be identified by color coded wrist bands.

Rental payment will be due in full at the time of booking. In addition, a separate deposit check will be required at this time.

GVRC will provide adequate lifeguard supervision, tables, chairs, grill, volleyballs and basketballs. Other recreational activities will need to be approved by the Pool Manager at the time of booking. Charcoal will be available for purchase at \$5 per bag. Rental of the propane tank for \$5

Renter and guests will comply with all governmental laws, ordinances, rules and regulations with respect with use of the facility. In addition, renter and guests will abide by all of the current rules and regulations of GVRC. Renter will be responsible for returning the rental area to a ready for use condition at the end of the designated time or they will forfeit their deposit of \$25.

All non-member guests are expected to vacate the premises at the conclusion of the rental period.

In the event that the renter does not perform their obligations under this agreement, the security deposit is forfeited. In the event that the renter does meet their obligations, the Pool Manager will return the security check at the end of the party.
